Orders for products other than standard cataloged items are "specials" and may not be cancelled under any circumstances after release for fabrication by the customer.

All purchase orders must be submitted to The RiteScreen Co., Inc. in written format and including the necessary billing and shipping information. No verbal orders will be accepted. The RiteScreen Co., Inc. will not be responsible for incorrect sizes and/or specifications written on the orders.

Delivery dates given by the Manufacturer are not guaranteed, expressed or implied, unless so stipulated in writing by an Officer of the manufacturer and if such dates are not adhered to, the order involved may not be cancelled at cost to the Manufacturer. Further, the Manufacturer cannot be held responsible for any customer liability arising from delays or failures in manufacturing or shipping, for any reason whatever, within or beyond our control.

Terms of Sale

PRICES AND SPECIAL QUOTATIONS: All prices, unless otherwise specified, are F.O.B. our Factory. Prices do no include Federal, State, or Local Sales, Use, Manufacturer's or other Excise Taxes, which may be imposed on the sale of our product.

NEW QUOTATIONS: Will remain in effect for 30 days only, unless otherwise agreed to in writing. All prices are subject to change without notice.

MINIMUM INVOICE CHARGE: All Orders entered with The RiteScreen Co., Inc. are subject to a minimum order charge of \$25.00 regardless of the equipment purchase value.

Terms of Payment

Standard terms of payment are: Net 30 days; from date of invoice. All invoices, even if disputed, are due and payable on the above terms. Disputed invoice amounts, if legitimate, will be credited accordingly.

The Manufacturer reserves the right to discontinue absolutely further sales directly to buyers where the above terms are not adhered to.

Until fully paid for, The Manufacturer expressly retains title to all materials to secure payment of purchase price and/or security interest in such materials under uniform commercial code when applicable.

Return Material – Re-Stocking

No product may be returned to the Factory for any reason without prior written authorization by management. All return shipments must be shipped prepaid regardless of the circumstances prompting the return; collect shipments will not be accepted.

Material returned to the Factory for credit is limited to standard stock items. No other items may be returned for credit. All such standard items are subject to a minimum re-stocking charge of 25% of the original purchase price. If returned materials are received in unacceptable condition for restocking, no credit allowance will be made. If the customer desires return of such material, it will be returned "Freight collect".

Products Warranty

Each product has a specific warranty – see complete warranty for details. No guarantees expressed or implied, other than herein stated or issued in writing by an Officer of the Manufacturer, shall for any purpose be binding upon the Manufacturer. The Manufacturer's products are warranted for a period not exceeding 90 days from the date of shipment, and only to the extent that we will furnish a new product to replace that which is proven defective by the Manufacturer. Replacement will be only made after the user or authorized distributor or representative has returned the alleged defective product at his expense to our Factory for examination. This warranty does not in any way include cost to remove the product from its final mounting place, nor does it include reinstallation costs of the replacement product.

No warranty is included against property, personal, or physical injury to any person or persons resulting from handling the product or as a result of improper installation.

Any back-charge of a legitimate nature so acknowledged by an Officer of the Manufacturer will only be paid on a prearranged basis in writing and not to exceed a duly authorized amount. Personnel of the Manufacturer (other than a Company Officer) or authorized independent Distributors and Representatives may not in any way assume authority as a spokesman for the company, nor shall they commit the Company to any back-charge or liability whatever. Such charges may only be accepted or authorized by an Executive Officer of the Manufacturer.
